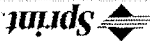
Wireless Instruction for Schools and Home (WISH) Pilot Project (Palms Royal 4)



Technology: Transforming Learning

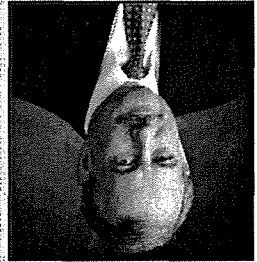
The WISH Project places pocket PCs in the hands of third grade students. Students use the hand held computers to complete accelerated reading tests, surf the Internet, and complete assignments given by the teacher via a Tablet PC and wireless connectivity. Using science probes, students also conduct science experiments. The students take the handheld computers home to complete their homework assignments and log-in to the network at school the next day to turn in their assignments. Using portable keyboards, students complete writing assignments using Pocket Word and chart their science experiment results in Pocket Excel.
