#### **AESA Educators Call to Action Conference in D.C.**

Join us for a very informative conference September 24-26, 2013 in Arlington, VA. Our panels of congressional staff members will address three key areas of interest to K-12 educators: ESEA, Budget/Appropriations, and Perkins. Members of these panels are invited due to the key position their member of Congress plays in moving these important issues. After the panel briefings, you will be off to Capitol Hill for visits to your members of Congress and their staff. Attendees can schedule visits with their congressional representatives.

On Thursday, September 26th, we will have a presentation from FCC Commissioner Jessica Rosenworcel who was sworn in, in May of 2012. She has declared herself as a champion of the schools and libraries program of the FCC's Universal Service Fund (more commonly known as E-Rate). Her past role as Counsel to the Senate Commerce Committee has prepared her well for this task. Her four-step program of improvements includes:

- 1. Increasing E-Rate funding
- 2. Providing every school access to 100 megabits per 1000 students by the 2015 school year
- 3. Encourage and institute new and creative public-private partnerships
- 4. Simplify the process for applicants

In addition, Attorney Chris Lott of Hogan Lovells will offer the always popular review of edcuational issues before the Supreme Court and the various Federal district courts.
