The Perkins Local School District is located in Perkins Township and also contains parts of five contingent townships. Originally a rural school district, most of the district's students now live in a suburban setting. With positive results for our students, the district initiated open enrollment 10 years ago to maintain and expand access to Perkins' excellent academic and extra-curricular programs. The district encompasses 49 square miles and has four buildings: Furry Elementary (Grades Preschool-2), Meadowlawn Intermediate Elementary (Grades 3-5), Briar Middle School (Grades 6-8), and Perkins High School (Grades 9-12). Approximately 72% of the district teachers have 10+ years of experience.
